Nominations for the **BOARD OF DIRECTORS** must be received at the SFS office for collection by the returning officer **not less than 14 days** prior to the date set for the AGM and will close at **4:00pm on Friday 1st October 2020.**

Nominations for **LIFE MEMBERS** must be submitted to the Board who may then recommend the candidate to the AGM. Nominations shall be lodged with the Secretary **not less than two (2) months** prior to the AGM. The Board will consider nominations for Life Memberships that are received **prior to the AUGUST 10th Board Meeting.**

Notification of nominations received will be posted on the Club notice board.

VOTING RIGHTS FOR ANNUAL GENERAL MEETING

ONLY ORDINARY MEMBERS* who are financial members and LIFE MEMBERS are eligible to vote. Please refer to the Articles of Association for exact definitions.

*ORDINARY MEMBERS are deemed to be:

- Financial SAILING MEMBERS 18 years of age and over, actively involved in sailing at the SFS, who have twelve (12) months continuous financial membership.
- Financial SOCIAL MEMBERS, 18 years of age and over who have three (3) years continuous financial membership.

In case of doubt as to the form of validity of any nomination or voting rights, the matter shall be referred to the Returning Officer, whose decision shall be final.
